- The petition must be signed in the same manner required by land conveyance. Names must appear <u>exactly</u> as they do on the property deed.
- The signatures must be properly notarized. Colorado statutes require compliance with all the above instructions.
- > The address of the entity owning the property must be provided.
- A \$750.00 fee will be collected upon submittal of any petition to cover legal, advertising and administration costs.
- The District reserves the right to request additional information needed to evaluate the petition and make findings required by law.
