Mr. Dennis Gatlin acting as the Chair, with Mr. Brian Zick, acting as the Secretary, called the meeting to order.

- The pledge of allegiance was said. Roll was called and it was determined that a quorum was present.
- 3. Mr. Chismar moved to accept the agenda as presented. Motion seconded. Motion passed [5-0].
- 4. Mr. Piira moved to approve the minutes of the July 16, 2018 special board meeting as presented. Motion seconded. Motion approved [5-0].
- Mr. Chismar moved to approve the minutes of the September 7, 2018 special board meeting as presented. Motion seconded. Motion approved [5-0].
- 6. There was no public comment.
- Ms. McCarty presented the Financial Reports ending July 31, 2018. There was discussion about streamlining account closings and customer refunds.
- 8. Mr. Zick and the management team presented administrative, operations, engineering and development activity for July and August. Progress reports for the CIPP lining project and the Wastewater Treatment Plant Expansion were also presented.

- Mr. Chismar moved to go into executive session at 11:46 am per §24-6-402(4)(f), personnel issues. Motion seconded. Motion approved [5-0]. District personnel left the meeting. Mr. Zick was asked to re-join the meeting near the end of the session. Session ended at 12:22 pm.
- 10. Mr. Piira moved to remove the "Interim" portion of Mr. Zick's title and appoint him District Manager for Boxelder Sanitation District. The board instructed Mr. Zick to follow up on the discussion of compensation for staff responsibilities in light of the departure of the previous district manager.
- 11. Mr. Zick and Ms. McCarty presented a first draft of the 2019 budget.
- Mr. Zier, Ms. McCarty and Ms. Davis left the meeting following the budget discussion.
 - 12. Mr. Piira moved to begin charging mobile home parks for each site at the current base rate of \$55/SFE and usage charge of \$3/1,000 gallons effective January 1, 2019. Motion seconded. Motion approved [5-0].
 - 13. Mr. Chismar moved to adjourn the meeting following lunch. Motion seconded. Motion passed [5-0].
